#### **ROLL CALL & INSPECTION**

#### 12:00 PM to 5:30 PM

Roll call is the time when participants are expected to check in. Check-in is followed by inspection for fitness, lameness, or "in season" females. Every dog must be inspected prior to EACH run. Handler will wipe female dogs. Roll call will open 15 minutes before your block is scheduled to run. If you do not check in before the end of your block, we will assume you are absent. There are no refunds for absent dogs. Bitches known to be in season are not to be brought to events and entry fees will be refunded.

#### AWARDS

A **light blue** ribbon will be awarded to each dog that completes the 100 yard dash. A rosette will be awarded for dogs that have finished a new title.

#### **ELIGIBILITY**

Only purebred Afghan Hound, Azawakh, Basenji, Borzoi, Cirneco dell'Etna, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Norrbottenspet, Peruvian Inca Orchid, Pharaoh Hound, Portuguese Podengo, Portuguese Podengo Pequeno, Rhodesian Ridgeback, Saluki, Sloughi, Scottish Deerhound, Thai Ridgeback, and Whippet that are one year of age or older and have been registered with The American Kennel Club or an AKC recognized foreign registry or that have been granted an Indefinite Listing Privilege (ILP) may be entered.

#### **CONDITIONS OF ENTRY**

- For these tests, only **SIGHTHOUNDS** are eligible.
- All entries must be one year of age or older on the day of the test.
- Bitches in season and lame dogs will be excused. Entries will be refunded.
- There will be a minimum \$25 returned check charge.
- A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress.
- A \$5.00 fine will be assessed for any handler not cleaning up after their dog.
- Gas powered, continuous loop equipment will be used.
- Lures consist of white plastic.
- MGA reserves the right to alter course due to field and/or weather conditions on the day of the test.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Test Committee.
- Children MUST be under control of their parents or guardians at all times.
- Only the Lure Operator, Huntmaster, and Handler of the dog running in the course in progress will be permitted near the lure machine.
- At its discretion, MGA may break periodically during the day to accommodate worker breaks.
- Handlers in Fast CAT are not permitted to travel down the 100-yard course during a dog's run or just prior to a dog being released for its run.
- The Finish: It is recommended that an owner or someone familiar with the dog stand at the finish in order to catch the dog once the course has been completed. A handler cannot recall their dog from the startline.

#### These will be CONCURRENT tests using a BLOCK SCHEDULE

NO RUN ORDER will be mailed out – a time block will be assigned and a run order will be created before the start of the time block. All entries with a valid, legible email address will be sent an entry confirmation with time block. It is the responsibility of each entrant to be ready with a catcher and releaser when their dog is called to the line. Dogs not checked it within 15 minutes of the start of their block time may be moved to a later time block.

#### **COURSE PLANS**

The field is located near the wave pool. There is plenty of parking next to the field. Please note that the park is NOT fenced and is public. The test field will NOT be fenced. The course (running lane and start box) will be fenced by temporary step in posts and plastic tape. Run out will be 60 yards, but will not be enclosed by fence. The running lane is grass.

Start and finish light curtain gates will be used for timing. Stopwatches will be used only if necessary, at the discretion of the test committee.

#### **HOW TO ENTER**

Complete an official AKC entry form for each dog for each test. Entry forms are located at the end of this premium list. Each dog may only enter once per test. **Enter early, as only 100 entries will be accepted for each test.** Make checks payable to "MGA" in US funds. Please note height of your dog at the withers on your entry form.

You may only enter by mailing all of the forms and fees to the Event Secretary or entering online via the Michigan Gazehound Association website, so that it is received by the closing date and time for entries. If your dog becomes lame, sick, or in season prior to the test, do not bring them to the test. Instead, contact the Event Secretary before the start of the tests to cancel your entry, and your entry fee will be destroyed or otherwise refunded. **Entering early is advised, as each test is limited to 100 entries.** 

Entries will not be accepted without fees, signatures, or the "Agreement" found on the Official AKC Entry Form. Follow your veterinarian's recommendations to assure that your dogs are free of parasites and any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

The Event Secretary must have the completed entry form and payment before a dog may be presented for inspection.

## **ROLL CALL & INSPECTION**

All dogs must be presented for inspection without tape, bandages, wrapping, or coverings of any kind (e.g., coats and blankets). At least two persons from the Test Committee will inspect each entered dog for lameness, fitness to compete, and female estrus (in season). In their opinion, any entered dog that is found to be lame, unfit to compete, or in season will not be allowed to run. Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are old, have breathing or heart problems, are overweight, or are out of condition may be at greater risk for injury and exhaustion. The entry fee will be refunded for any dog that is not allowed to run by the inspectors. All dogs will be measured, with a wicket, to determine handicap. This measurement is final for this event. Your dog will be inspected and measured before EACH event.

Roll call will open 15 minutes before your block is scheduled to run. If you do not check in before the end of your assigned block, we will assume you are absent. Any dog that fails to present for inspection prior to the close of roll call and inspection for that time block will be marked absent. No refund will be given for an absent dog.

## **PADDOCK**

It is the intention of the test committee to begin running courses as soon as roll call and inspection begin. When you are ready to run your dog, bring them to the paddock, the assembly area for dogs that have passed inspection and are prepared to run. Dogs may run wearing a

close fitting buckle collar. Choke collars and collars with dangling decoration will not be allowed. Hanging collar tags may be permitted if they are secured tight to the collar, such as by tape. Slip leads can be used if the owner desires

The Paddock Master determines the order in which dogs run. After passing inspection, you must check in with the Paddock Master to ensure that your dog has been placed in the running order. In general, the Paddock Master will identify the next available dog based on the order in which they checked in to the paddock. In particular, preference may be given to a dog that is running its first test of the day over a dog that is running its second test of the day. If a dog is not present when it is called to run its test, the dog's name will be moved to the end of the running order. After roll call and inspection closes, any entered dog that has not yet tested and is not present within 5 minutes of completion of the last course will be marked absent and no refund will be given.

# **RUNNING THE COURSE**

Each dog runs by itself and only one time in each testing event. They chase lures made of plastic strips that, by string and pulleys, follow a course in a field. Exhibitors must provide two handlers, one to release the dog in the start area and one to retrieve the dog in the finish area.

The Huntmaster is responsible for field safety and, therefore, is in complete charge of the dog and handlers on the field. In service to this responsibility, the Huntmaster has the authority to stop the lure at any potentially dangerous situation and signal the handlers to retrieve their dog. The handlers should retrieve their dog promptly at the end of the course. Listen to the Huntmaster and follow their instructions promptly and swiftly.

Handlers are not permitted to run with a dog, whether inside or outside of the course, and must remain either at the start or finish area of the course, except, if necessary, to retrieve their dog. Also, handlers must refrain from using devices as enticements while a dog is running the course. You may not enter the start area with your dog until your catch handler is in the finish area.

The FastCAT is a timed test. Light curtain timing equipment will be used at both the start and finish lines of the course. MGA reserves the right to use stopwatches in the event that the timing equipment malfunctions.

For the safety of the dog and as a courtesy to other exhibitors, your dog should have a reliable recall. A penalty of \$5.00 may be assessed for any dog causing an excessive delay of the event, because it cannot be recalled or retrieved from the field. Dogs that delay the event because they cannot be recalled may be refused entry at future events.

# **AKC TITLES**

The dog's time is converted to mile per hour by formula and adjusted by a height handicap to determine a point score. Three titles will be awarded for dogs as they accumulate points in Fast Coursing Ability Test events. These are suffix titles that will appear on a dog's pedigree with a higher-level title superseding a lower-level title.

FORMULA: 204.545 / RUN TIME = MPH
MPH X HANDICAP = POINTS (ROUNDED TO NEAREST 0.01)
Based on the dog's size at the withers, a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Below 12" = Handicap is 2.0.

#### MPH X HANDICAP = POINTS

Titles are earned at specific point levels and the highest suffix may appear after the dog's name: BCAT = 150 points DCAT = 500 points FCAT = 1,000 points FCAT# = Each additional 500 points
