

DIRECTIONS TO THE SITE

Field is accessed on E Main St by the southeast gate to the Fairgrounds—23801 E Main St is an approximate address.

From I-69 – Exit at Capac Rd (Exit 176). Go South on Capac Rd to Armada Center Rd, turn left. Go East on Armada Center Rd to Fulton St/North Ave, turn right. Go South on Fulton St/North Ave to Main St, turn left. Go East on E Main St to southeast entrance of Fairgrounds on left.

From I-94 – Exit at M-19 (Exit 247). Go Northwest on M-19/Main St/New Haven Rd to North Ave, turn right. Go North on North Ave to Main St, turn right. Go East on E Main St to southeast entrance of Fairgrounds on left.

From M-53 – Exit at 32 Mile Rd. Go East on 32 Mile Rd to North Ave, turn left. Go North on North Ave to Main St, turn right. Go East on E Main St to southeast entrance of Fairgrounds on left.

ROLL CALL & INSPECTION

Trial Hounds at 8:30 AM.

Early acceptance of hounds for members of the field committee may begin ½ hour prior to the times listed above.

RIBBONS

First – Blue, Second - Red, Third - Yellow, Fourth – White, Fifth - Pink.
Best of Breed - Purple & Gold Rosette.
Additional prizes may be offered by the club or friends of the club.

ELIGIBILITY

Only purebred Whippets that are one year of age or older and have been registered with The American Kennel Club or an AKC recognized foreign registry or that have been granted an Indefinite Listing Privilege (ILP) may be entered. Breed disqualifications apply.

TESTS OFFERED

No tests—Junior Courser (JC) or Qualified Courser (QC)—will be offered.

STAKES OFFERED

OPEN: Open only to Whippets, with no breed disqualifications, that hold an AKC QC certificate OR have run in the Open Stake prior to Jan. 1, 2010, OR have a Senior Courser title OR have an ASFA or CKC field champion title (a copy of this title must be attached to the entry form if the QC requirement is to be waived) OR have an ASFA Hound Certification (a copy of which must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake. Hounds under disqualification from AKC, ASFA or CKC Field Trials may **NOT** be entered.

SPECIALS: Open only to Whippets that are eligible to enter the Open Stake **and** have earned their AKC Field Championship title. LCX points may be awarded from this stake. Hounds under disqualification from AKC, ASFA or CKC Field Trials may **NOT** be entered.


VETERAN: Open only to Whippets that are eligible to enter either Open or Specials Stake, and are of Veteran age as determined by their Parent Breed Club (7 years for Whippets). Championship or LCX points may be awarded from this stake. Hounds under disqualification from AKC, ASFA or CKC Field Trials may **NOT** be entered.

SINGLES: Will not be offered.

BEST IN FIELD (BIF): Will not be offered.

All dogs run at owners' sole risk. The hosting clubs and property owners, their agents, members, representatives, volunteers, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors and handlers or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

COURSE PLAN



Course will be reversed for finals, run-offs and BOB.

The field committee reserves the right to alter the course due to field and/or weather conditions on the day of the trial.

NOTICE TO ALL EXHIBITORS

All entries must be one year of age or older on the day of the trial. Registrations cannot be pending.

Hounds not present at the time of roll call will be scratched after a 5-minute grace period and no refund will be given.

Stakes may be split if sufficient entries are present in any one stake at the time of the draw to support more than one 5-point major.

Bitches in season and lame hounds will be excused. Entries will be refunded. These are the only reasons that pre-entries will be refunded after the pre-entry closing date.

There will be a minimum \$25 returned check charge.

Hounds will be checked for breed disqualifications. Spayed and neutered hounds are eligible to participate. Monorchid and cryptorchid hounds are ineligible to participate.

A \$5.00 fine will be assessed for any loose hound on the field that is not competing in the course in progress.

A \$5.00 fine will be assessed for any handler not cleaning up after their hound.

The field is not fenced; adequate shade and cool/drinking water should be provided by the participants.

Gas or battery powered, continuous loop equipment will be used. Lures consist of white or black plastic.

Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running in the course in progress will be permitted near the lure machine.

Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Committee. Children **MUST** be under control of their parents or guardians at all times.

Four clubs are hosting AKC lure coursing events on this weekend. On Saturday and Sunday, Michigan Gazehound Association (MGA) is hosting AKC lure coursing trials and tests; the premium for those events may be found on either akc.org or michigangazehound.com. Concurrently on Monday, American Whippet Club (AWC) is hosting a Whippet specialty lure coursing trial, Basenji Club of America (BCOA) is hosting a Basenji specialty lure coursing trial, and Raisin River Rhodesian Ridgeback Club of Michigan (RRRRCoM) is hosting a Rhodesian Ridgeback specialty lure coursing trial. Instructions and forms for camping are included in the premium for MGA.

All entries for AWC, BCOA, and MGA must be paid to MGA, either by check or online, as directed in their premiums. All entries for RRRRCoM must be completed on paper, signed, and submitted with checks made out to RRRRCoM. RRRRCoM will not accept e-mail entries. All camping fees must be paid separately to MGA and may be submitted with entries to any of one of the four clubs.
